



## EDUCATION

**The Current Fees from 1<sup>st</sup> September 2020 are:**

### **IAT FE and HE Education**

#### **Course Registration Fees £100.00 plus VAT**

Student registration onto one of the IAT Level 2,3, 4, 5 or 6 qualifications or Apprenticeships are required to pay a course registration fee, this is collected by the selected education provider at point of registration. The IAT will collect the fee from the educational provider.

The fee will include registration to the qualification, issue of original certification on successful completion of qualification.

*These fees do not include the Providers Cost for teaching. Please contact Provider for Fees.*

#### **Replacement of certificates £40.00**

Replacement certificates will only be supplied once authenticity of both applicant and successful completion have been verified by the Chairman of the Board of Moderators. A fee will be charged for all replacement certificates and must be paid prior to certificate being re-issued.

**Please Note.** *Replacement of certificates awarded prior to 2007 may occur additional cost, quote will be provided on application.*

#### **NACWO certificates £15 each**

The fee will include issue of original certification on successful completion of qualification. Fees are normally collected by the provider

## Membership

### **The Current Fees until 31<sup>st</sup> Dec. 2021**

The Institute membership year runs from 1st January to 31st December.  
New applications processed after 1st October are automatically entered as members for the following year.

Candidates who have completed IAT qualifications must be fully paid up members by 1st April of the year of their qualification in order to be eligible for specific membership status.

Membership not renewals by 1<sup>st</sup> of March will be classed as a lapsed member and will not be entitled to any IAT benefits until payment received. However, for 2020 due to the exceptional circumstances of Covid-19 and the transition to the new database, renewal invitations went out much later than planned. Please rest assured that no



memberships will have lapsed or been affected. For 2020 only, we would expect membership fees to be paid by July 2020.

As there is no longer an official retirement age, no arbitrary age limit can apply for the retired rate. Members wishing to take advantage of the Retired Rate should contact the IAT Administrator ([admin@iat.org.uk](mailto:admin@iat.org.uk))

**Please Note.** Members with RAnTech status must be a paid up member of the IAT to be a Registered Animal Technician and use RAnTech after their name. Lapsed membership may result in Members needing to apply to be re-certified as a RAnTech.
